The New Mexico Academy of Science (NMAS) and its partners, the New Mexico Experimental Program to Stimulate Competitive Research (NM EPSCoR) and New Mexico Alliance for Minority Participation (NM AMP), invite abstract submissions on **Sustainable Energy Development in New Mexico** and **The Water, Energy, and Environment Nexus** for presentation at the NMAS Research Symposium in Albuquerque, NM, 1 November 2014!

To be eligible to present, you must be registered for the meeting <u>link to registration</u>. Abstract submissions for oral and poster presentations are due by **30 September 2014**. Please follow the guidelines below for preparing and submitting an abstract.

Abstracts

- Abstracts must be uploaded online as a Word document (.doc or .docx).
- You will be informed by 10 October 2014 if your abstract has been accepted.
- Please read and understand the difference between oral and poster presentations to ensure that you submit an abstract for the correct session type.
- Abstracts must describe the presentation's purpose, methods, results, and conclusions.
- Format your abstract according the example provided below.
- Abstracts are limited to 250 words.
- Abstracts should include 3 to 5 keywords.
- Abstracts should be carefully reviewed prior to submission for any spelling, grammatical, and typographical errors.
- Use the active voice for your abstract and presentation. Write clearly and concisely. Avoid jargon. SACNAS has helpful resources for writing abstracts and making

- By submitting an abstract, you are granting NMAS, NM EPSCoR, and NM AMP permission to publish it in the abstract compilation and to disseminate it electronically.

Oral Presentations

- An **oral** presentation provides the problem statement, objectives, methods and data, results, and conclusions of your original research using PowerPoint or other visual presentation software.
- Each oral presentation is allotted 20 minutes including discussion.
- Computers and projectors for oral presentations will be provided in each meeting room at no charge.

Poster Presentations

- A poster presentation is a **visual** presentation of a problem statement, objectives, methods and data, results, and conclusions of your original research.
- Posters are exhibited for informal browsing with opportunities for individual discussion with poster authors.
- Posters must not be larger than $3' \times 4'$.
- Room for poster presentations will be provided at no charge.

Abstract Format

Body of Abstract

Use Times New Roman, 12 point font, single spacing, with one inch margins 250 words maximum

Do not use abbreviations, all caps, or bulleted lists

Keywords: [list 3-5 keywords relevant to your research]
